STANDARD AGREEMENT

1. Dog owner understands and agrees that in admitting Owner's dog(s) to my doggies daycare, said business has relied on Owner's representations that Owners' dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dog.
2. Dog owner understands and agrees that they are solely responsible for any harm caused by their dog(s) while their dog(s) is/are attending my doggies daycare.
3. Dog owner understands and agrees that during the normal dog play day, their dog may sustain injuries. All dog(s) play is carefully monitored by facility staff to avoid injury, but injuries can and do occasionally occur, in spite of the best facility supervision.
4. Dog owner understands and agrees that neither my doggies daycare or any of its facility staff (employees) or volunteers will be liable for any dog illness, injury or death, as well as escape of owner's dog(s). Reasonable care and precautionary measures will always be followed. Dog owner hereby releases my doggies daycare and its facility staff and/or volunteers from any liability of any kind arising from owner's dog attending my doggies daycare.
5. Dog owner further understands and agrees that any behavioral and/or health problems that develop during their dogs stay, will be handled and treated in the best interest of the dog by the facility staff and/or volunteers. Any treatment will be the sole discretion of the staff and/or volunteers. Dog owner fully understands and agrees to assume the full financial responsibility for any and all expenses (medical or otherwise) arising from or relating thereto. This will include aggressive and destructive behavior.
6. Dog owner further understands and agrees that dog(s) will at ALL times, while attending my doggies daycare have current vaccinations. Dog owner further understands and agrees that even if dog(s) is/are vaccinated for Bordatella (kennel cough), there is always a chance that the dog(s) can still contract kennel cough. Dog owner agrees that he/she will not hold my doggies daycare responsible if dog(s) contracts Kennel Cough.
7. Dog owner further understands and agrees that dog(s) is/are required to be spayed/neutered (after age 7 months) in order to enroll at my doggies daycare.
8. Dog owner further understands and agrees that it is the dog owner's responsibility to leave an adequate supply of food during the dogs stay while at my doggies daycare. Further, it is the dog owner's responsibility to leave enough medication for dog(s) during the dog(s) stay at my doggies daycare. Should any food and/or medication supply be needed, dog owner authorizes my doggies daycare to purchase said items, and dog owner WILL be responsible for the cost and a fee to administer per occurrence.
9. Dog owner further understands and agrees that my doggies daycare reserves the right to use a "bark" control device, gentle leader and/or a similar program if their dog(s) create a disturbance to surrounding areas.
10. Dog owner understands and agrees to pay the rate for services rendered on the date that their dog(s) were checked into my doggies daycare. No pet will be released until ALL charges have been paid in full. Cancellation fees may be applied to any "no shows" or any reservations cancelled with less than 24 hours notice. Dog owner shall be liable for all fees incurred for the care and/or maintenance of their pet listed on this agreement. The dog owner agrees to pay any and all reasonable attorney fees incurred by my doggies daycare for the collection of any services and charges incurred while their dog(s) were at the facility.

11. Dog owner further understands and agrees that if dog(s) is/are not picked up by the end of **my doggies daycare** regular business hours, the dog owner understands and authorizes **my doggies daycare** to take whatever action deemed necessary for the continuation and care of owner's dog(s). Dog owner further agrees to pay **my doggies daycare** for all costs associated with the continued care of their dog(s). Furthermore, dog owner understands that if he/she does not pick up their dog(s) as scheduled, **my doggies daycare** shall be authorized to proceed according to California Civil Code section 1834.5 (Abandoned animals, disposition; notice), by with this section provides as follows:

"Notwithstanding any other provision of law, whenever any animal is delivered to any veterinarian, dog kennel, cat kennel, pet grooming parlor, animal hospital, or any other animal care facility pursuant to any written or oral agreement entered into after the effective date of this section, and the owner of such animal does not pick up the animal within fourteen (14) calendar days after the day time animal was to be picked up, the animal shall be deemed abandoned. The person into whose custody the animal was placed for care, shall try first, for a period of not less than ten (10) days to find a new owner for the animal, and, if unable to place animal with new owner, shall thereafter humanely destroy the animal abandoned. There shall be a notice posted in a conspicuous place or in conspicuous type in a written receipt given, to warn each person depositing an animal at such animal care facilities of the provisions of this section."

12. Finally, dog owner understands and agrees that each and every one of the foregoing provisions contained in items #1 through #12 above shall be in force and effect and shall apply to each and every occasion on which dog owner boards and/or deposits his/her dog(s) with **my doggies daycare** for care, extended boarding, grooming and/or training, as the case may be; and that this agreement shall remain in full force and effect between the parties until and unless otherwise cancelled or superseded by as written stipulation agreed to and signed by both parties.

Dog owner hereby certifies and agrees that they have read and understand all the rules and regulations set forth above, and that dog owner has read and understood this agreement, and each of its terms and conditions and has agreed to abide and be bound by these rules and regulations.
